AN ORDINANCE AMENDING  
THE MUNICIPAL OFFENSE CODE OF THE VILLAGE  
OF YATES CITY, KNOX COUNTY, ILLINOIS.

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF YATES CITY, KNOX COUNTY, ILLINOIS:

Section 1: AMENDMENTS TO ARTICLE II OF THE MUNICIPAL OFFENSE CODE

The Municipal Offense Code adopted by Ordinance of the Village of Yates City, being Ordinance No. 2015-717, passed and approved May 14, 2015, is amended so that a Section 9.22 C shall hereafter read as follows:

C. REGISTRATION OF NON-HIGHWAY VEHICLES.

(1) No person shall operate a golf cart, all-terrain vehicle or recreational off highway vehicle on any street or roadway within the Village of Yates City without first obtaining a permit from at least one of the following:

(i) The Village Clerk of Yates City; or,

(ii) Any municipality or county located within the State of Illinois which has enacted an ordinance which is substantially similar to Section 9.22 of this Code.

(2) Permits issued by the Village of Yates City shall be subject to the following:

(i) Except as otherwise provided in this section, permits shall be issued for a period of one (1) year. The term of the permit shall be from the 1<sup>st</sup> day of April to the 31<sup>st</sup> day of March the following year. Each permit issued later than April 1<sup>st</sup> shall terminate on March 31<sup>st</sup> the following year, but said permit fee shall not be diminished or prorated.

(ii) The permit fee shall be \$25.00 (per year). Said fee shall be paid by check or money order made payable to "Village of Yates City."

(iii) The existence of the required insurance coverage shall be verified by the Village Clerk when issuing or renewing a permit.

(iv) A single day Special Event Permit may be issued. There shall be no cost for such a permit.

(3) Every application for a Village of Yates City permit shall be on a form supplied by the Village and shall contain the following information:

(i) The name and address of the applicant;

(ii) The name of the liability insurance carrier;

(iii) The serial number, make, model and description of the non-highway vehicle;

(iv) A photostatic copy of the liability insurance coverage card issued by the insurance carrier specifically applicable to the non-highway vehicle; and,

(v) Such other information as the Village may reasonably require to ensure compliance with this ordinance.

(4) No Village of Yates City permit shall be issued until the non-highway vehicle has been inspected by the Village Chief of Police, or his designee, to ensure that the vehicle is safe to operate on Village streets and is in compliance with the requirements of Section 9.22 B(2)(i) hereof.

(5) A physically handicapped applicant requiring a golf cart modified with hand controls must submit a certificate signed by a physician that the handicapped applicant is able to safely operate a motorized golf cart in compliance with this Section.


(6) The Village may suspend or revoke a Village of Yates City permit granted hereunder upon a finding that the holder thereof has violated any of the provisions of Section 9.22, or if there is evidence that the holder thereof cannot safely operate the non-highway vehicle on Village streets.

Section 2: CONFLICTING ORDINANCES


All ordinances and parts of ordinances in conflict herewith are hereby repealed.


